1. Parties and Purpose

This Stud Service Agreement (the "Agreement") is entered into between Bubba Dub Kennels (the "Stud Owner") and the person identified above (the "Female Owner"). The Stud Owner agrees to make Bubba Dub available for approved stud service subject to every term of this Agreement. This Agreement does not create a partnership, joint venture, agency relationship, co-ownership arrangement, or ownership interest in any resulting litter.

2. Stud Identification and Documentation

Stud: Bubba Dub, American Pit Bull Terrier. **Registry:** ADBA. **Sire:** 15886AP-01 Wiggins "Peacock." **Dam:** 152629AP-62 T.C. & R.B.S. "Dirty Mary." **Bloodline:** Jeep x Monster G. Registration documentation and pedigree verification are available upon request for approved breeding inquiries only.

3. Stud Fee and Payment

The total stud fee is **One Thousand Two Hundred Fifty Dollars (\$1,250.00 USD)**. A **\$250.00 non-refundable reservation deposit** is required to hold an approved appointment. The remaining **\$1,000.00 balance** must be received in cleared funds before any stud service begins. Accepted forms of payment are cash, Zelle, cashier's check, or certified bank check. Personal checks, post-dated payments, payment plans, puppies, and pick-of-litter arrangements are not accepted unless a different arrangement is expressly stated in a separate writing signed by both parties.

4. Female Health and Eligibility Requirements

Before service, the Female Owner must provide truthful and current information concerning the female's identity, age, reproductive status, temperament, vaccinations, and health. A current negative Brucellosis test and any other documentation reasonably requested by the Stud Owner must be provided before breeding. The Female Owner represents that the female is free from contagious illness, is physically suitable for breeding, and is under appropriate veterinary care. The Stud Owner may postpone or refuse service when health, safety, temperament, compatibility, or welfare concerns exist.

5. Timing, Transportation, and Veterinary Expenses

The Female Owner is responsible for determining the female's fertile period, arranging transportation, remaining available for scheduling changes related to the heat cycle, and paying all veterinary, testing, collection, shipping, artificial insemination, boarding, travel, and reproductive expenses unless otherwise agreed in writing. The Stud Owner does not guarantee the accuracy of timing selected by the Female Owner or the Female Owner's veterinarian.

6. Method and Performance of Service

The service method and number of breeding attempts will be agreed upon before the appointment and documented when applicable. All handling will be conducted with reasonable care and attention to the welfare of both dogs. The Stud Owner may stop or decline a procedure if continuing would present an unreasonable risk to either dog or any person.

7. No Pregnancy or Litter-Size Guarantee

Animal reproduction is uncertain. The Stud Owner does not guarantee conception, pregnancy, live birth, litter size, puppy sex, color, health, quality, temperament, marketability, registration eligibility, or fitness for any particular purpose. Except for any written repeat-service provision stated below, the stud fee is earned when the agreed stud service is performed.

8. Limited Repeat-Service Provision

If the female does not become pregnant, the Stud Owner may, at the Stud Owner's discretion, provide one repeat service to the same female on her next suitable heat, provided that: (a) the Stud Owner receives written veterinary confirmation of no pregnancy; (b) the Female Owner complied with all terms of this Agreement; (c) the same female remains healthy and eligible; (d) Bubba Dub remains available and medically fit; and (e) all new testing, veterinary, collection, shipping, boarding, and related expenses are paid by the Female Owner. No cash refund is required. A repeat service is non-transferable and expires twelve months after the original service date unless extended in writing.

9. Stud-Service-Only Scope

Bubba Dub Kennels provides stud services only. The Female Owner retains sole responsibility for the female, pregnancy management, prenatal and veterinary care, whelping, newborn and puppy care, litter registration, advertising, sale, placement, contracts with puppy buyers, taxes, and compliance with all applicable laws. The Stud Owner has no ownership interest in any resulting litter and no obligation to handle, raise, market, sell, place, or guarantee puppies.

10. Assumption of Risk and Limitation of Liability

The Female Owner understands that breeding and animal handling involve inherent risks, including injury, illness, infection, infertility, pregnancy complications, loss of pregnancy, and loss of animals. To the fullest extent permitted by law, each party is responsible for that party's own dog, conduct, property, and expenses. The Stud Owner is not liable for indirect, incidental, special, consequential, or lost-profit damages. Nothing in this Agreement waives liability that cannot legally be waived.

11. Indemnification

To the fullest extent permitted by law, the Female Owner agrees to defend, indemnify, and hold harmless Bubba Dub Kennels and its owners, agents, and representatives from third-party claims, losses, liabilities, costs, or expenses arising from the Female Owner's dog, the resulting litter, puppy ownership or placement, misrepresentation, breach of this Agreement, or violation of law, except to the extent caused by the Stud Owner's willful misconduct or liability that cannot legally be excluded.

12. Cancellation, Rescheduling, and Default

The \$250.00 reservation deposit is non-refundable because it compensates the Stud Owner for administrative work and holding appointment availability. If Bubba Dub is unavailable because of illness or another circumstance within the Stud Owner's control, the Stud Owner may offer a rescheduled date or refund the deposit. Failure to provide required documentation, pay the balance, appear as scheduled, or comply with safety instructions may be treated as cancellation by the Female Owner.

13. Photographs, Records, and Privacy

The Stud Owner may retain service records and communications for business, legal, and animal-welfare purposes. No registration certificate or pedigree document may be copied, altered, or used to misrepresent ownership. Photographs or identifying details of the Female Owner or female dog will not be used publicly without permission, except as reasonably necessary to enforce this Agreement or comply with law.

14. Governing Law; Venue; Entire Agreement

This Agreement is governed by the laws of the State of Georgia, without regard to conflict-of-law principles. Any action concerning this Agreement must be brought in a court of competent jurisdiction in Georgia, unless the parties agree in writing to another lawful dispute-resolution method. This Agreement and any signed written addendum constitute the entire agreement and supersede prior oral or written statements. Any amendment must be in writing and signed by both parties. If any provision is unenforceable, the remaining provisions remain effective.

15. Acknowledgment

Each party confirms that the party has read this Agreement, understands it, has had an opportunity to ask questions and seek independent legal or veterinary advice, and signs voluntarily. This template is a private service agreement and is not a substitute for advice from a licensed Georgia attorney or veterinarian.
